SITUATION REPORT

A selection of recent reports from Sri Lankan newspapers, without comment, Readers are requested to form their own conclusions.

Tamil Doctor held

"Police took in for questioning a Tamil doctor in connection with the alleged video taping of the Colombo Dockyard and the Kochchikade Rangalla Naval facility by a group of foreigners.

A Tamil woman resident in Colombo was also taken in for questioning in this connection. Meanwhile the foreigners involved in the incident were released on a request made by the Ambassadors of their respective countries in Sri Lanka. These foreigners, however will not be permitted to leave the country. Police will keep a strict check on those foreigners. Police yesterday questioned the doctor to establish whether he had any connections with Northern Tamil terrorists. (The Island-13.5.86).

Tamil, Clerk held

"The Criminal investigations Department (CID) yesterday took into custody a Tamil wharf clerk attached to the Customs Department for questioning in connection with the Air Lanka Tristar bomb explosion which occurred on May 3rd and claimed the lives of 17 persons, of whom many were foreigners. Sources said that suspect from Kayts was closely associated with the two Customs officers who were now considered prime suspects in connection with the blast..." (The Island-14.5.86).

8 Tamils held in Colombo

"The CID yesterday took into custody at a house in Bullers Road, Colombo 7 eight Tamils suspected to have terrorist links. Sources said they were Tamils from Jaffna and kayts and were involved in printing Eelam literature at the time they were nabbed. The literature and the machinery, were taken into custody, CID sources said. Sources said the house in which the literature was printed was that of an ex-Corporation Executive. (The Island-17.5.86).

Tamil Policeman held

"A Tamil Police Constable attached to the Jaffna police is reported to have been taken into custody over the Airlanka bomb explosion. Police sources said yesterday that the CID acting an intelligence reports arrested the PC at the Pannai Police Quarters last week. He is reported to have come to Colombo a day before the blast and was involved "in certain

events surrounding the blast" said the sources who refused to elaborate. But Police said the CID believes he was an informant for the terrorists". (The Island-26.5.86).

160 Tamils sent on leave

"Over 160 Tamil employees of the Sri Lanka Broadcasting Corporation are to be sent on special leave for an indefinite period from tomorrow according to SLBC Chairman Mr. Livy Wijemanne. Mr. Wijemanne said that letters informing them of such leave specifically states that it is not compulsory leave. He said that the employees are being directed to go on leave in their own interests, as they could be forced to act against the institution..." (The Island-18.5.86).

Tamils moved out of airport duty

All Tamil Customs officers have been transferred out of the Colombo International Airport, Katunayake, with effect from today. They will be posted to other branches of the Department, a senior Custom official told "Sun". The move followed the alleged involvement of three Customs officers in the bomb explosion aboard the Air Lanka Tristar on May 3. Meanwhile, at least 80 punchers used by Customs officials to seal export goods after being checked, have disappeared from the Department, sources said. (Sun-20.5.86).

Helicopter shot at

"The helicopter in which the Joint Operations Command (JOC) Chief, Lieutenant General Cyril Ranatunge was travelling in, to meet members of the Jaffna Citizen Committee, was yesterday shot at by terrorists Palaly on two occasions, security sources said. Although there was no injury inflicted on the JOC Chief the helicopter received minor damages, security sources added. Mr. Ranatunge was to meet the Jaffna Citizens' Committee members to discuss the present conflict in the North, sources said. However, his helicopter was shot at when it took off from Palaly, on the first instance at 11.30 a.m. and on the second instance at 2.00 a.m. Security sources said that several terrorists have been reported dead in Kayts, following battles with the Security forces. (The Island-21.5.86).

Helicopter crashes

"A security force helicopter at the Elephant Pass camp crashed to the ground yesterday morning after rising a few feet on take-off, injuring its seven persons in it including its

crew, according to security sources. The injuries to the crew were reported not serious said the source. (The Island-23.5.86).

Army-civilian clash in C'bo

Three people including a soldier were killed and at least 15 others injured in a clash which police said was between Army personnel and a group of civilians at Slave Island last night. An elderly woman was also among the dead. Police and Army closed all entrances to Slave Island last night, as the injured were rushed to the General Hospital. Two soldiers were among the injured, police said... The Military police had to be called in to quell unrest at the hospital after the victims of the clash were brought in. Later, the Fire Brigade was called to douse a burning lorry and a car near the Slave Island roundabout. (Sun-21.5.86.)

Colombo under security blanket

The city of Colombo has come under a tight security blanket following reports of possible attempts to bomb vital locations, police sources said. Police have intensified vehicle checks and more road blocks have been placed while deploying more officers to strengthen security in and around the city, they said... Meanwhile, motorists and pedestrians were put to severe inconvenience yesterday as traffic clogged the highways in the city... (Sun-22.5.86)

Bomb scare at Royal College

Confusion and panic reigned in the heart of the city last morning, as police personnel from four stations were rushed to investigate a bomb scare at Royal College and about 8,000 students were evacuated from the school. A massive search was launched by about 100 policemen in the sprawling 30-acre school after Principal C.T.M. Fernando got an anonymous telephone call that a bomb had been placed in the premises... Traffic ground to a halt in the immediate vicinity and the college was placed under police guard on the orders of National Security Minister Lalith Athulathmudali after the bomb call was found to be a hoax. School officials said the college would re-open on Monday. (Sun-22.5.86)

School bags banned

Bomb scares have compelled certain Principals of schools to ban the use of school bags by students. However a Ministry of Education spokesman said the act on the part of Principals was improper and unjust. The Ministry

Events from March 27 — April 10 were carried in Issue No. 11 of Situation Report

APRIL 11

Keeping a steady volley of fire in all directions, more than hundred soldiers from Palaly army camp march up to Harbour View Hotel camp at Kankasanturai, while helicopters fly low providing aerial cover. There was no response from Tamil militants.

In the East, 2 soldiers killed and 6 injured in an LTTE attack on an army foot patrol at Kat-taiparichchan in Mutur district.

7 Buddhist priests abducted while fasting in Colombo yesterday found dropped at different places outside the city.

Residents living near temporary army camp at Omanthai vacate homes in fear.

2 small ships with predominant blue and yellow colours seen for 3rd day off the northern Kankasanturai coast.

In Colombo, Sinhala newspaper "Divayina" carries report quoting "official" sources that Jaffna's Palaly airport will be made an international airport with U.S. and British aid, and that the runways will be extended to the Myliddy coast to facilitate movement of all three forces - Air Force, Navy and Army. The eventual objective, according to the report, is to carve out the northern fringe of the peninsula into a "security operations zone"

Shops at Nelliady close - in memory of TELO commander Dhars and other TELO militants gunned down at Jaffna hospital premises on this day last month.

APRIL 12

Administrator of the Sankilian refugee centre in Jaffna Dr. Sasitharan reported to be arrested by Naval personnel while going on a boat with refugees, and produced at Trincomalee Police station.

Hindu temple at Punanai on the Batticaloa-Polonnaruwa road near the army camp is now used by STF as a check post.

In search operations by armed forces now camping at govt. school in Triyai, north of Trin-

comalee, one Tamil youth Subramaniam Rajaratnam was killed and another, Velu Selliah injured. Incidents occurred on April 10.

Timekeeper at Batticaloa railway station, Johnpulle, father of 5 children, shot dead at his home by an unknown youth.

Lt.Gen.Cyril Ranatunge, General Officer commanding the Joint Operations Command, tells Colombo newspaper "SUN" that because of the daily offensives by separatist guerrillas pounding government military camps in the north, his men were now awaiting orders to engage the guerrillas in battle. He says he had been "pulling in the reins on his troops due to the ongoing political process and what he referred to as "good people of Jaffna."

In an island-wide test held for selection as Police Sergeants, only three Tamils are selected as against 262 non-Tamils. The selected Tamils are N.T. Namasivayam, V. Pakianathan and Kulathilakarajah. (Éalamurasu)

APRIL 13

Men of the armed forces in civils surround a house yesterday at Thiruvaiyaru 2nd culvert in Kilinochchi district and take away nearly hundred bags of paddy to the army camp.

If the govt. was honest enough to arm the proposed Provincial Councils with sufficient powers, he was prepared to persuade Tamil leaders to accept them, says a former SLFP Education Minister Dr. Badiudin Mahmud, at a meeting of Muslim leaders in Colombo.

Abandoned houses of residents in Valalai, Thampalai close to Thondamanaru army camp are set on fire by black uniformed armed forces; at Palaly, where also residents had been forced to flee and abandon their homes, houses are destroyed and in some places produce-bearing trees are cut down to make way for temporary roads to facilitate movements of armoured cars and army vehicles.

A young Tamil woman Vanaja Var-nakulanathan(21) of Mutur, who was allegedly tortured by men of the armed forces is sent to Jaffna hospital for emergency treatment by

Trincomalee Citizens Committee.

A gang of about 30 armed, masked men rob the house and business premises of trader T.A. Apputhurai at Kankasanturai, and get away with jewellery and items worth several lakhs. Apputhurai who was a victim of the anti-Tamil riots in Colombo in July '83, had thereafter set up business in Jaffna.

APRIL 14

Sinhala and Tamil New Year. The day passes without any major incidents being reported barring a half-hour helicopter strafing in Myliddy Palaly areas.

In Moratuwa, suburb of Colombo, Officer-in-charge of Police Station, Inspector Earl Peiris is shot dead by a Sergeant working under him.

APRIL 15

Farmer Sinniah Nandakumar (32) who went to Nilayeli from his home village Kumburupitiya to buy fertiliser on the 13th and reportedly "arrested" by armed forces on that day, found dead with gunshot injuries. His body was brought to Trincomalee hospital.

Decomposed body discovered in jungle area at Mankulam identified as that of Mathiaparanam Jegan (22), an employee of an eating house, who had been missing for the past three days following a "search" operation by army personnel.

Three soldiers killed and four others injured in a landmine explosion at Niyankulam in Batticaloa near the Polonnaruwa district border. Killed soldiers were Lance Corporal Anwerdeen, Lance Corporal Sahabandu and Pvt. J.L. Panditharatne.

Y.P. Arumainayagam of Poonakari "executed" as an army informer and his body tied to a lamp post.

Residents of Thunnalai form Vigilance Committee to prevent robberies and decide to set

road blocks between 10 p.m. and 4. a.m.

Army men who had set up camp at Nainativu engage local civilian going on a boat to Kurikadduvan to buy food and provisions for them. At Kurikadduvan the money was robbed at gun-point, and on reporting back the civilians and the boat are detained by army personnel.

APRIL 16

For 27 days now - since March 21 - no poojas or religious rites held at the Sellasannathy Hindu temple. Smell of rotting corpses in temple vicinity. Temple priests, Citizens Committee complain to Jaffna G.A. and ask for shifting of army camp away from the temple.

Helicopter strafing again, in the north. Villages affected: Mallakam, Tellipallai, Kadduvan and Kurumbacitty. Several persons injured, a leading school, Union College and several houses damaged.

S. Ravindrarajah (23) of Point Pedro an LTTE fighter killed, hit by a shell from the Point Pedro army camp.

Homes of Selliah Balasubramaniam and Nalathambay Ratnasabapathy at Kachcheri-Nallur Road, Jaffna, robbed by armed gang, and over Rs. 4 lakhs worth jewellery and cash taken away.

In Trincomalee district, 60 Tamil families living near the 3rd Mile army check post at Nilaveli forced to abandon their homes. With refugee camps full, they are now become vagrants. Another 1,000 families, residents of Chelvanayakapuram Colony are under army orders to leave.

Jungle at Omanthai in the mainland north are being set on fire, and trees and vegetation destroyed by army men who have set up camp in the area.

Following a drunken brawl among army personnel at Abeyapura in Trincomalee district, four army men admitted to Trinco hospital with stab injuries.

APRIL 17

Six persons killed in Jaffna following army offensives from two army camps - the Dutch Fort and Navatkuli, and over a dozen injured.

The killed are, a 4-year old child and a youth, Arudpiragasam (23) both killed by army shells in their homes, at Navatkuli, 2 soldiers, Karunaratne (30) of Kurunegala and Abhayasiri (28) of Mirigama, and two LTTE militants, Lt. Gerry (S. Yogarasa) and Murali (N. Kamalanathan) both of Chavakachcheri, who were killed in action at Navatkuli. Three other soldiers, Cyril Perera (31) of Negombo, Weerasinghe (35) of Kelaniya and Gamini Appahamy of Polgahawela believed critically injured.

Earlier in the day Muslim Tamils of Jaffna stage a mass protest march condemning U.S. bombing of Libya and burn the American flag opposite the government secretariat. All shops close in sympathy.

An apparently drunken man, a Sinhalese, Wijeyaratne Douglas who walked with a gun into the Mudalikulam Tamil refugee camp in Trinco district, shouting that all Tamils should be killed and began firing at random and who was overpowered by his own wife who had rushed behind him, is produced before Trinco Additional magistrate M.K. Sellarajah. He is remanded until April 28.

Helicopter strafing of Kadduvan, Myliddy and Kurumbacitty areas, continue.

Unknown persons set fire to Poonakari Maha Vidyalayam. School records and part of the buildings destroyed.

APRIL 18

7 Air Force personnel and 2 civilians killed in landmine explosion on the Trincomalee-Anuradhapura road, and another two airmen seriously injured. The party was travelling in a truck and a jeep from the Morawewa Air Force camp to Anuradhapura for supplies. The dead were 4 leading aircraftsmen and 3 Corporals. The LTTE which set off the explosion estimates the death toll as 23. Elsewhere in the East, Sub Inspector of Police Kurunbalapitiya was killed at Pottuvil, when a hand grenade was flung at the jeep in which he was travelling.

Was a Tamil youth beaten to death by army personnel opposite the army camp at Navatkuli? Eyewitnesses say a youth estimated to be around 22 years old who was cycling from the direction of Kaithady towards Jaffna, wearing a blue shirt and white sarong, was stopped by army men, tied to a tree opposite the camp

and beaten repeatedly with rifle butts and kicked with booted feet. After some time when he seemed unconscious, they were seen sprinkling water on him and feeling his pulse. He was seen being untied and dragged inside the camp.

4 Tamil youths, Rasa, Maharasa, Periathambay and Amalan, all of Chelvanayakapuram in Trinco district, taken away by armed forces.

Armed gang of 15 hold up 8 passing vehicles including a govt. bus, at Miyankulam in Batticaloa district and rob all passengers.

Govt. claims that a "terrorist" identified as Thevaranjan of TELO was captured in Colombo.

SLFP retains the Akmeemana seat in Parliament defeating the ruling UNP.

APRIL 19

The government's home Guards scheme introduced into Tamil-majority areas is reported to be collapsing slowly. Unemployed Sinhalese, and in some areas Muslims, were given a brief training, a shot gun each and ordered to keep a vigil for "terrorist activities", on a payment of Rs. 40/- per day. These "Home Guards" are now being found not only to be ineffective, but an additional menace to the civilian population. In many cases the guns have been taken back and payments stopped.

Three women and a man were killed and their bodies displayed opposite the Senaiyur refugee camp at Kaddaiparichchan in Mutur district. A placard near the bodies read: This is the fate that awaits those who give information about freedom fighters to the armed forces.

A Tamil militant group is believed to be responsible for the spiriting away of 400 Commando uniforms from a laundry at Arasady Junction, Batticaloa.

A Tamil fisherman, A. Joseph who was engaged in fishing near the Senthankulam coast in the north was caught by navy men, who deprived him of his catch and his net and released him after a severe beating.

Kandiah Rasadurai of Chettiar Madam, Araly, complains in a newspaper advertisement (Eelanadu) that an armed gang of youths had robbed his home and had taken away not only

cash, jewellery and TV, but also air tickets, passports, Identity cards of his four grown-up daughters whom he had planned to send to Malaysia. He appeals to the "good" militant groups to help him recover at least his daughters' documents, without which his daughters would face a bleak future.

Hotel Ashok in Jaffna and a restaurant in the bazaar area Amuthasurabi hotel, were both damaged partially by shelling from the Dutch Fort army camp. Over Rs. 1 lakh damage was caused to these two buildings as well as others.

Another Air Force man injured in the Morawewa landmine explosion succumbs to his injuries at the General Hospital, Colombo.

It is estimated that there are 55,000 Tamil refugee in the Jaffna peninsula, comprising 16,000 families, 5,000 of whom are in camps and others outside camps.

Govt. claims that two "terrorists" belonging to the EPRLF were killed in Thikkodi in Batticaloa by "security forces" who also recovered two grenades and EPRLF literature.

APRIL 20

Kantalai reservoir in the Eastern province burst its bund at dawn this morning, leaving at least 25 dead and rendering at least 30,000 persons homeless. Waters inundate vast areas including some 35 villages and 21,500 acres of paddy and sugarcane. Both road and rail links between Trinco and Colombo cut off. Minister of National Security Lalith Athulathmudali rules out sabotage. Emergency refugee camps set up.

At Point Pedro, four soldiers and 2 LTTE militants killed in an encounter. Heavy shelling from the sea follows, making people flee inwards.

In Vavuniya, shops close in protest against repeated robberies.

In Matale, in the plantation area, a former Mayor, a Tamil, S. Thambirajah is killed and his wife critically injured when hand grenades were flung at their home by unknown persons.

APRIL 21

A day of unmitigated terror and tragedy at northern coastal town of Thondamanaru. 8 sol-

diers killed and several others injured, the temple chariot and temple buildings destroyed by aerial fire, an officiating Brahmin priest and his assistant stripped by army men and killed, and several civilians feared dead or injured. The day of tragedy began at dawn around 5 a.m. when LTTE guerillas spotted an army unit from the Thondamanaru camp moving stealthily in the direction of the temple. LTTE guerillas mounted an offensive at the moving column, encircling them in 3 directions, killing at least 8, injuring several more and forcing them back into the army camp. A day-long reprisal followed. While a plane flew low over the area, and was challenged by rocket fire, a black helicopter from Palaly began strafing the temple vicinity, while the army men from the camp kept shelling continuously. In the evening around 6 p.m. 14 bombs were dropped in the temple area, destroying the chariot built recently at great expense with public donations. Other temple buildings also damaged. Elsewhere in nearby areas helicopters began strafing at all moving vehicles. A team of high-ranking army officials reported to have flown from Colombo late in the evening to investigate the day's happenings.

In the Kantalai bund burst disaster, it is now feared that those who lost their lives might be in the region of a few hundreds

At Kilinochchi, a large army convoy in 15 armoured cars and trucks move in a show of strength firing in the air, causing panic in several villages.

About 15 police commandos admitted to Valaichchenai hospital in the East, with minor injuries following a surprise attack on them by Tamil militants in a place called "Pulipainthakal". One Commando who sustained serious injuries was flown to Colombo.

Batticaloa-Amparai Citizens Committee to submit the names and details of 341 persons known to have "disappeared" after being arrested by armed forces, to the military Co-ordinating officer.

APRIL 22

Following the day-long incidents at Thondamanaru yesterday, the entire area seems denuded of human population. In Colombo government authorities accuse Tamil militants of having used the temple as a cover to attack

the armed forces and also accuse the militants of having set fire to the chariot! A lone helicopter flies low in the area today, and thereafter strafes every moving vehicle in the nearby villages. Meanwhile concern was expressed by military authorities in Colombo that the body of one soldier who was killed was not recovered.

Bodies of two Sinhalese civilians among the four who were kidnapped at Kinniya near Trinco, discovered with gunshot injuries.

The unknown youth who was beaten up by army men opposite the army camp at Navatkuli on the 18th has now been identified as 23-year old Vadivelu Sinnathurai of Madduvil. But the Navatkuli authorities deny knowledge of the youth.

APRIL 23

Colombo and Anuradhapura, 120 miles apart, rocked by two bombs. 9 persons killed in Anuradhapura, and in Colombo nine escape with injuries. A bomb suspected to have been concealed in a petrol bowser from Jaffna rips through the Ceylon Petroleum Corporation's oil storage facility at Anuradhapura and sets off a major fire, blowing up two more petrol bowsers and causing extensive damage to the complex. The bomb in Colombo was in an unclaimed travelling bag in a private bus and exploded when a hasty policeman meddles with it at the Wellawatte police station.

Following the Anuradhapura explosion, thugs set upon several lorries and buses plying between Jaffna and Colombo, causing a complete stoppage of road transport between north and south.

In the north, Brigadier Rupasinghe is persuaded to see for himself the massive destruction suffered by the venerated Hindu shrine of Sellasannathy. The Brigadier who came by helicopter to the army camp opposite, is met by G.A., Jaffna who had motored there with Citizens Committee members. Brigadier sees the temple's 40-foot wooden decorative chariot built with the help of Indian sculptors at a cost of Rs.45 lakhs now a large mound of ash; in the temple outer courtyard he sees two human skeletons; the large temple prayer bell fallen from the belfry and lying scattered in pieces. The temple area which used to throb with human activity is now a picture of desolation. Temple trustees and Citizens Commit

tee members hold the view that there was no point discussing re-opening the temple for public worship as long as the army was camped opposite it.

In yesterday's "search operation" at Visvadamu, armed forces kill Narayanasamy Ravindran (21) and Joseph Gunaseelan (20), both employed at a dairy outlet at Visvadamu junction, bomb and destroy a building on the main road near Chundikulam junction. A helicopter and plane provide aerial cover.

In a "search operation" involving over a thousand soldiers and over five villages in Ampara district, 58 Tamils were taken away on a "head nodding signal" by a masked person.

APRIL 24

Eelam Revolutionary Organisation (EROS) through its spokesman V. Balakumar claims responsibility for the blast at the State-owned Ceylon Petroleum Corporation storage facility at Anuradhapura yesterday, and warns that many more such operations would be undertaken to cripple the Sri Lanka economy, unless the govt. stops its acts of terrorism against Tamils. The damage to the Corporation is estimated at Rs. 3.5 million.

It is now known that apart from two petrol bowsers from the north which caught fire in yesterday's explosion, five other bowsers from Tamil areas parked in the yard outside had been deliberately set on fire by miscreants. A Tamil lawyer Thamu Kanagasigam and another Tamil who had come to board a train at Anuradhapura station were set upon by thugs in the station premises and were admitted to hospital in an unconscious state.

Protest procession in Jaffna against the kidnapping 20 days earlier and holding to ransom of Mascons Director Ganeshan by unidentified militant group.

In the course of a "search operation" in Mandur in Batticaloa district, armed forces rob two Hindu temples, one of them the ancient and celebrated Mandur Kandasamy Temple. Booted soldiers break open into the sanctum sanctorum into which even the Hindu worshippers are not admitted, rob several lakhs worth gold ornaments break open the temple till, assault the temple priests and terrorise the local population. Urgent protest telegrams sent to Minister of Hindu Affairs in the govt. Chelliah

Rajadurai.

A Hindu monitoring group, set up in Nallur, Jaffna, is now engaged in collecting all data relating to destruction of Hindu temples, robbing of temples and acts of sacrilege both by Sinhala mobs during the '77 riots as well as by armed forces since then.

APRIL 25

Prof. K. Sivathamby of the Valvettiturai Citizens Committee takes strong objection to a major subversion of truth in the Govt. T.V. - the Rupavahini, involving the incidents at Sellasannathy Temple. In a strongly worded statement made to the G.A. Jaffna, in whose presence Brigadier Rupasinghe had inspected the damage to temple property, Prof. Sivathamby expresses shock how the burnt chariot, the splintered temple bell, the burnt roof had all been suppressed in the film. Instead, an impression was sought to be created that the temple priest was **not** killed by showing Balendra Iyer when in fact it was the senior priest Sinniah Kurukkal and his assistant who were killed. The Rupavahini feature was a deliberate falsification of the truth, Mr. Sivathamby says. Many other TV viewers also express anger.

Enraged by the Rupavahini programme on the Sellasannathy temple on the 24th, Seenikutty Kathirgamanathar (48) of Pannalai, Jaffna, takes a home axe and breaks up his own TV set. Kathirgamanathan is reported to be a life-long devotee of the Sellasannathy temple.

16 Tamils and 4 Sinhalese have been taken into custody in connection with the bomb explosion at Anuradhapura.

Several fishing boats beached off Mathagal and Senthankulam on the northern coast are damaged by helicopter fire.

Four armed unknown persons rob the Bank of Ceylon, Vavuniya of Rs.1 lakh and nine thousand. Despite resistance offered by bank security and other staff, the robbers get away with the loot.

Thousands of rotting carcasses of animals in Kantalai are causing an unbearable stench and a health hazard. Medical teams rushed from Colombo to prevent outbreak of epidemics. International Red Cross survey says 2,500 persons are still missing.

Colombo newspaper "SUN" says 14 "terrorists" were killed in raids by armed forces in jungle hideouts in Batticaloa district.

Thondamanaru areas again subject to helicopter attacks.

In Batticaloa, one of the main road bridges, the Paddiruppu road bridge, is blasted by a bomb. Explosion heard for 20 miles around, say reports. About 125 villages in Paddiruppu cut off from direct access as a result.

Kaththankudy Multi-purpose co-operative store robbed of Rs. 2 1/2 lakhs worth goods by armed gang. Kaththankudy is a Muslim majority area and it was only recently 75 Home Guards were appointed for this area from local residents.

The presence of soldiers at Maviddapuram junction causes stir among the public. They had apparently come to hire a lorry to offload goods from a ship at the KKS harbour, but had quickly gone back.

Continuous shelling from morning till noon from the Pt. Pedro army camp. No casualties. The objective appears to have been to destroy buildings in the neighbourhood.

Tamil constable Thurairajah attached to Alutgama police station dies of gunshot injuries at Alutgama. No details available.

Tellipallai residents angry over night robbery at the home of Cement Factory engineer S. Thevaratnam who lives next to the Post Office. Gang of about 20 armed youths force their way into house, assault the engineer, abuse his wife and engage in brutal behaviour before taking away cash and jewellery. Residents put up road blocks and stage a protest. Mr. Thevaratnam's neighbour's house also robbed at the same time.

Jaffna Municipal employees who went to investigate unauthorised tapping of electricity at Arasady Road, Nallur, set upon by unknown persons. Commissioner appeals to the youths and Citizens Committee to identify the offenders.

has laid down certain rules to ensure the safety of students and schools but it has never told school authorities to ban school bags. All that the Ministry wanted was to check the bags at the entrance to the schools he added. Several parents have reported the action of the principals to the Ministry which is to investigate the complaints shortly. Some school principals confiscated bags brought in by students in a bid to discourage the practice of bringing bags to school. (Sun-22.5.86)

Fire at Garments factory

A major fire at a garment factory at Ekala on Friday night destroyed machinery, finished garments and a store house of dress material causing an estimated Rs. 5 million in damages. The fire was finally brought under control by the Colombo Fire Brigade with the assistance of air force personnel stationed in Ekala and the Ja-Ela Police. According to Police the fire which started around 2.30 a.m. destroyed nearly 500 sewing machines and a large stock of finished garments... (Sun-26.5.86)

Another detention camp

Government is to set up another detention camp to accommodate suspects arrested under the Prevention of Terrorism Act. The existing camp in Boosa is overcrowded, a Defence Ministry source said, explaining the need for another camp. The new camp is likely to be located at a site in Pelawatte in the Kalutara district where land and buildings are available. They had earlier been used on an agricultural project which has been wound up. The official said the camp at Boosa which at present houses terrorist suspects is crowded. Hence the Ministry feels more suspects should not be sent there since it would cause congestion and administrative problems... (Sun-28.5.86)

Motorcycle bandits

Two helmeted motorcyclists snatched a bag containing Rs. 130,000 from two employees of a car sales company outside the People's Bank foreign branch at Bristol Street, Fort last afternoon. According to Police, the employees from the company in Bambalapitiya, who were travelling in a jeep, had earlier withdrawn the money from the People's Bank Kollupitiya and had gone to Fort to deposit the money. They were walking towards the Bank when the motorcyclists, on one motorbike had snatched the bag and ridden off, police said... (Sun-30.5.86)

Bottle parcel creates panic

A parcel in a toilet at the Liberty Plaza last morning caused panic in this crowded shop-

ping complex and led to the evacuation of people on the first floor, while the army bomb disposal unit conducted investigations. The parcel contained a few empty bottles, Police said. But the hoax is not being taken lightly in view of an incident reported on Tuesday night. In this incident, a parking warden who gave a driver a ticket had been threatened by the car's occupants that a bomb would be placed at the complex, police said. The parking warden has then taken down the car number and reported the matter. Investigations are underway, Police assured. (Sun-15.5.86)

'Rag' bags cause panic

Two travelling bags in a private coach caused panic at the Pettah bus stand yesterday and the army's bomb disposal experts were summoned to investigate. Traffic was halted and the area evacuated while the two unattended bags were checked. Both bags were filled with rags and police believe it was a deliberate attempt to cause a bomb scare. Meanwhile, Borella Police called the army bomb disposal unit when the crew of a private coach reported the presence of an unaccompanied parcel. Police closed the road to the Borella junction and the area was cleared. But what they found in the parcel was not a bomb but the rain coat of a police officer. The incident occurred around 7 p.m. yesterday. (Sun-28.5.86)

Job agencies fraud

Some fraudulent job agencies earn as much as half a million rupees daily Labour Minister P.C. Imbulana revealed yesterday. They charge each client Rs. 15,000 to Rs. 20,000 and deceive them with false promises the Minister said. He said the Ministry had intensified its efforts to nab these agencies and appealed for public co-operation. The Ministry, he said would shortly formulate scheme to ensure the compulsory registration of all persons seeking employment abroad at the Foreign Employment Bureau at the Foreign Employment Bureau Mr. Imbulana said. The Minister was speaking at a meeting of Foreign Employment Bureau officials. (Sun-28.5.86)

Cigar merchants suspected

Galle Police have launched an investigation to ascertain whether a consignment of petrol and diesel obtained in Galle by traders from Jaffna were meant for terrorists. A group of one traders had come to Galle recently from Jaffna with a lorry load of cigars and tobacco. They had delivered these items and filled bar-

rels of petrol and diesel from two filling stations in Galle, SP Galle, W.A. Weeraratne told 'SUN'. Police have received information that the fuel barrels had been transported under

a stock of poonac. Galle police also obtained information regarding the vehicle in which the said merchants had come and other occupants of the vehicle. A stock of diesel worth Rs. 40,000 and a stock of petrol worth Rs. 34,000 had been collected from two fuel stations Police sources said. (Sun-17.5.86)

More bomb scares

Bomb hoaxes at two business establishments caused panic among employees yesterday. The army bomb disposal squad was called yesterday morning when employees of the City Bank at Kollupitiya found an unclaimed brief case on a counter. The squad which arrived a few minutes later cleared the office. But found that the brief case contained documents. A telephone call warning employees of Airlanka's office at the Mercantile building in Fort that a bomb was placed in the office also caused panic. They were evacuated from the office and the army bomb disposal squad searched the office, but no bomb was found. (Sun-20.5.86.)

Escape of Key suspect

A key suspect in a terrorist cum southern Marxist plot to set off bomb explosions in Colombo has escaped from a southern police station. Police Headquarters yesterday ordered a found probe on the escape as a massive search was launched for the southern youth who is said to have undergone guerrilla training in a terrorist base in Tamil Nadu. The five main targets this group sought to attack were, the Rupavahini Corporation, Sri Lanka Broadcasting Corporation, Bank of Ceylon, Headquarters, Registration of Persons Department and Airlanka office in Fort. According to police since his escape several anonymous telephone calls have been received by police stations in the south demanding the release of the other four members of the radical group who were trained in Tamil Nadu. Police have launched a massive search in the south to locate his hideout officials said. Meanwhile, police investigators have questioned a woman in connection with the explosives haul for which the son of a former Sri Lankan Tamil diplomat is being held. The woman, police said, was the mother of the person who had been occupying the premises at which the gelignite was found. The man has disappeared. The Avissawella police have also launched a search for eight more members of this group. This includes the leader of the radical group, police said. The group had allegedly been responsible for two robberies last year Rs. 165,000 from a bank in Deraniyagala and Rs. 400,000 from an estate in Udabage. The group had also planned to set up an underground arms and ammunitions dump at Wenappuwa and to send another 15 youths for training in South India. (Sun-30.5.86)
